(1) This List of Conditions forms an integral appendix of the General Business Terms and Conditions. For users of the UniCredit Doktorok or Közös Érték Package, the currently valid documents titled 'List of Conditions for Small Business Customers', 'List of Conditions for Electronic Services for Small Business Customers' and 'List of Conditions for Debit Cards for Small Business Customers' shall apply to the types of transactions and services not included in this List of Conditions and the due dates of the fees, costs related to the individual services. Each fee indicated in the Bank's list of conditions is automatically adjusted once a year, with effect from 1 March of each year, by the annual average consumer price index (inflation) for the previous calendar year published by the Central Statistical Office (KSH) on its website. For reasons of business policy, the Bank is entitled to apply fees that are more favorable to the client, unlike automatic fee changes. The Bank shall inform its clients of the fact of the fee change and the modified rate of the relevant fees at least 15 days prior to the entry into force of the change by means of an announcement and a list of conditions published on its website and branches.

(2) Fee calculation method: 0,01% of the monthly credit and debit entries, minimum the indicated amount. The Bank waives the right to charge more than the minimum amount indicated on a promotional basis\*.

(3) The standard fee is HUF 1841 / month / account, which is not charged by the Bank on a promotional basis\*.

- (5) For HUF deposits in large amounts at the cash desk (cash deposits of more than a thousand HUF banknotes, for the full amount), the fee set out in the current 'List of Conditions for Small Business Customers' applies..
- (6) The Bank waives the one-off monthly fee for access to the telephone banking service and the monthly service fee.
- (7) The Bank waives the Issuer and First Annual Membership Fee, on a promotional basis\*, for the first MasterCard Business debit card applied for.
- (8) In the case of HUF payments in international payments (credit and debit), the Bank applies the conditions applicable to foreign currency payments.
- (9) Act CXVI of 2012 on the Financial Transaction Duty (FTD Act).
- (10) The extent of the fee shall be in line with the extent and maximum of the current financial transaction duty (including the additional financial transaction duty). If the legal regulations change, the Bank shall immediately modify the extent and the maximum amount to the same extent as that of the change.
- (11) In the case of cash withdrawals with debit cards, the bookkeeping fee per line applied as per the "Account management fee in the case of other transactions" shall apply as set out in the currently effective document entitled 'List of Conditions for Small Business Customers'.
- (12) In the case of each bank account statement and other mail sent to the customer. The Bank waives the fee for the number of items specified in the account package on a promotional basis\*. The postal charges for statements and other items sent after 1 statement per month are free of charge and are subject to the postal tariff in force at the time, details of which are set out in Annex 1 to the list of conditions entitled 'List of Conditions for Small Business Customers'.
- (13) The Bank waives the monthly management fee for the payment account on a promotional basis\*.
- (14) When switching from one of the packages in this List of Conditions to another account product. In the case of switching between HUF account packages, the pricing of the new account package is effective from the first day of the following month only.

If the Account Holder receives a promotional gift or a one-off credit in connection with the opening of this bank account, as announced in advance, and terminates this bank account within the period specified in the promotion notice, the Bank may charge a penalty equal to the value of the gift or one-off credit to their bank account.

In the event of any discrepancy with the Hungarian language list of conditions, the Hungarian language List of Conditions shall prevail.
