<sup>1</sup> This List of Conditions forms the integral appendix of the bank's General Terms and Conditions. For those using the UniCredit Paragrafus Package, the currently valid documents titled "List of Conditions for Small Business Clients", "List of Conditions for Electronic Services for Small Business Clients" and "List of Conditions for Debit Cards for Small Business Clients" shall apply to the types of transactions and services not included in this List of Conditions and to the due dates of the fees and costs related to the individual services. Once a year, the Bank shall increase all fees specified in its lists of conditions by an amount exceeding the annual consumer price index published by the Central Statistical Office (KSH) by 15 percentage points, one calendar month before the announcement of the relevant list of conditions, from which the Bank may deviate in favour of the client.

<sup>2</sup> The account opening fee is charged only one time for each account by debiting the account at account opening.

<sup>3</sup> Fee calculation method: 0.01% of the monthly credit and debit entries, as a minimum the indicated amount. As a promotional offer, the Bank shall waive the right to charge any part above the minimum amount. This promotional offer is valid until withdrawn.

<sup>4</sup> The normal fee is HUF 1,776 /month/account, and, as a promotional offer, the Bank will not charge this fee. This promotional offer is valid until withdrawn.

<sup>5</sup> For each bank account statement and other mail sent to the client. As a promotional offer, the Bank will not charge the fee on the number of transfers as specified in the account package. This promotional offer is valid until withdrawn. After sending the free-of-charge 1 bank account statement per month, the postage fee for additional statements and other mails sent out shall be according to the currently valid postal fees.

<sup>10</sup> As a promotional offer, the Bank will not charge the issuer fee for the first Corporate Maestro bankcard. This promotional offer is valid until withdrawn.

<sup>11</sup> The conditions valid for FX payments will be applied to cross-border HUF payments (debit and credit entries).

<sup>13</sup> For cash withdrawals with debit card, the fee applied according to the "Account management fee in the case of other transactions" shall apply.

<sup>14</sup> The extent of the fee shall be in line with the extent and maximum of the current financial transaction duty. If the legal regulations change, the Bank shall immediately modify the extent and the maximum amount according to the extent of the change. The fee portion in excess of HUF 21 or 30 will be indicated in a separate line of the bank account statement: non-cash transactions are indicated with "PTI", card payment transactions with "POS" and cash transactions with "PTIKP".
