With respect to the Dobbantó and TrendY account packages, the fees listed in the List of Conditions for Retail Customers for the Private Plus account package shall be applicable to all fee items not listed above. The due dates for the fees charged are outlined in UniCredit Bank's List of Conditions for Retail Customers.

Once a year, the Bank shall increase all fees specified in its lists of conditions by an amount exceeding the annual consumer price index published by the Central Statistics Office (KSH), one calendar month before the announcement of the relevant list of conditions, by 15 percentage points, from which the Bank may deviate in favor of the customer.

¹ The Account Holder shall be entitled to the conditions listed for the Dobbantó account package until reaching the age of 18, with the proviso that the Bank shall, without sending separate notification to the Customer, modify these conditions, on the first day of the month following the month in which the Customer turns 18, to the conditions of the TrendY account package valid for private individuals on that given day* and from that time on the prevailing conditions of the TrendY account package shall be applicable to such Customer.

* As part of a promotional offer, the Bank shall modify the conditions applicable to the Customer on the first calendar day of the year following the calendar year in which customer turns 18, to the conditions of the TrendY account package valid for private individuals on that given day. This promotional offer is valid until revoked.

² The Account Holder shall be entitled to the conditions listed for the TrendY account package until reaching the age of 26, with the proviso that the Bank shall, without sending separate notification to the Customer, modify these conditions, on the first day of the month following the month in which the Customer turns 26, to the conditions of the Bonus account package valid for private individuals on that given day** and from that time on the prevailing conditions of the Bonus account package shall be applicable to such Customer.

** As part of a promotional offer, the Bank shall modify the conditions applicable to the Customer on the first calendar day of the year following the calendar year in which customer turns 26, to the conditions of the Bonus account package valid for private individuals on that given day. This promotional offer is valid until revoked.

The maximum transaction and daily limit amount that can be set by the Customer is HUF 100,000 for debit cards applied for not later than 17 February 2014. The maximum transaction and daily limit amount that can be set for debit cards applied for after 18 February 2014 is HUF 150,000. The legal guardian of the Customer of minor age may exclusively be the card holder, if an application for a secondary card is made.

⁵ Fee calculation method: 0.01% of transactions, but at least the amount indicated above. As part of a promotional offer, the Bank shall not charge the amount exceeding the minimum amount indicated. The discount is valid until revoked.
